MARINA RULES AND REGULATIONS

A restroom and separate shower facility is located at the top of the second set of stairs on the south side of the building. The combination for Restroom and Free WIFI login will be given to you at check-in. Check-in and Check-out time is 11:00 am. The Club Manager can give permission to delay departure time until after lunch if the slip is not reserved for an incoming boat

- 1) Overnight dockage is limited to 2 consecutive nights unless special arrangements have been made with the Clubs General Manager.
- 2) Captiva Island Yacht Club is not responsible for any loss or damage to any docked vessel or property kept or stored on the boat, the dock, or elsewhere.
- 3) Any member, guest, or others using the marina agree that they shall do so at his or her own risk, and shall hold harmless CIYC for any and all loss, cost, claim, injury, damage, or liability sustained or incurred by him or her, resulting from any act or omission of the Club, employees, representatives or agents, or members of the Club.
- 4) Owners of boats using the docks are responsible for seeing to it that their boats are secured and present no danger to themselves, the dock, or other vessels.
- 5) No vessel, or portion thereof, shall protrude beyond the dock or beyond the land/lease of the CIYC. Inquire about details from the Club Manager or the dock attendant.
- 6) Boat owners are responsible for damage to the dock structure, pilings, etc.
- 7) Canvas, sails, etc. must be secured so as not to make noise.
- 8) Boat owners are responsible for the conduct of their guests and for any damage caused by their guests.
- 9) Noise shall be always kept to a minimum. Discretion is to be used when operating motors, generators, radios, and TV sets, etc.
- 10) Swimming, diving, and fishing are prohibited at the dock or in the general area.
- 11) Laundry shall not be hung out on boats or on the docks.
- 12) Bicycles and other items that inhibit or endanger walking on the dock are not permitted on the docks. Bicycle riding on the docks is also prohibited. Dock lines and hoses are to be neatly coiled so as not to inhibit or endanger walking on the dock.
- 13) Open fires are not permitted on the boats or on the docks.
- 14) Pets are permitted only if they do not disturb other dock guests, CIYC members, or employees. When ashore, pets are to be leashed. Pet owners are responsible for cleaning up any excrement deposited by their animals.
- 15) **Tween Waters Resort** now requires all visiting boaters to have a day pass (\$25 per person) to use **Tween Waters'** facilities. The passes can be obtained at their front reception desk upon arrival.

Dress Code Policies: Bathing suits are not permitted in the clubhouse at any time, but are permitted on the Commodore's Porch with a cover-up until 6:00 p.m. No hats on gentlemen at dinner. Yacht casual attire is long pants, collared shirts for gentlemen- slacks, skirts, or dresses for ladies. **No blue denim is allowed in the club at any time.** Shorts are permitted during the summer season (after Mother's Day to September 30th.)

Docking Charges:

The length of a boat is defined as the overall length, including bow pulpits, swim platforms, and dinghy davits.

Florida Council of Yacht Clubs:

Dockage: one night at no charge; thereafter \$3.50 per foot per day.

Daily charge for cable, electric and water: \$15.00 per day.

CAPTIVA ISLAND YACHT CLUB ENVIRONMENTAL POLICIES

Strict adherence to the Environmental Policies provided is of paramount importance as a condition for using the marina. The boat captain is solely responsible for securing his vessel and adhering to all Coast Guard and State of Florida Rules and Regulations including No Discharge Rules and Regulations.

MANATEES

- The safety of Manatees and other sea mammals is of prime importance.
- Do not attempt to feed or touch them. Also, do not squirt water at them from a hose. These activities, which might be well intended, are actually harmful to sea mammals and interfere with their normal instincts and behavioral patterns.
- When traveling the local waterways, be aware of manatees, follow safe boating rules, and do not speed.

SEWAGE

- The discharge of sewage at our docks is strictly prohibited.
- Sewage is to be stored in holding tanks and disposed of after departure at a pump out station or in accordance with the regulations of the State of Florida and the United States Coast Guard.

WASTE DISPOSAL

- All refuse is to be placed in garbage bags prior to disposal.
- Refuse is to be disposed of in the dumpster behind the yacht club or in marked containers.
- The disposal of hazardous material is not permitted.

OVERBOARD DISCHARGE

- There shall be no discharge of any substance except for clean bilge water and clean water from sinks and showers.

FISH CLEANING

- Fish cleaning is not permitted.

MAINTENANCE AND REPAIRS

- Other than emergency repairs, only routine minor maintenance is permitted for boats using the CIYC Marina.
- No maintenance that inhibits the enjoyment of others using the dock is permitted.
- Maintenance that has a negative environmental impact is prohibited.
- No fuel trucks are permitted on CIYC property
